DAY 1: DEPART FOR KRAKÓW

Begin your pilgrimage with an overnight flight to Kraków, Poland, preparing for a meaningful journey of faith, history, and spiritual discovery.

DAY 2: KRAKÓW

Arrive in Kraków and meet your local guide for the transfer to your hotel. Enjoy time to rest before gathering for a welcome dinner and overnight.

DAY 3: KRAKÓW / DIVINE MERCY SHRINE / JOHN PAUL II CENTER

Explore Kraków's sacred and historic landmarks, including Wawel Cathedral and Castle, the Archbishop's Palace, St. Mary's Basilica, Collegium Maius, and the Old Town Market Square. Continue to the Divine Mercy Shrine in Łagiewniki, where Mass will be celebrated at the Chapel of Relics. Visit the nearby John Paul II Center before dinner and overnight in Kraków.

DAY 4: CZESTOCHOWA

Travel to Cestochowa to visit Jasna Góra Monastery and the revered Shrine of the Black Madonna. Celebrate Mass at the Chapel of the Black Madonna before returning to Kraków for dinner and overnight.

DAY 5: AUSCHWITZ / WADOWICE

Visit Auschwitz to reflect on the life and martyrdom of St. Maximilian Kolbe. Continue to Wadowice, birthplace of Pope St. John Paul II, before returning to Kraków for dinner and overnight.

DAY 6: WIELICZKA / VELEHRAD / BRNO

Visit the remarkable Wieliczka Salt Mines, known for their underground chambers and chapels carved from salt. Continue into the Czech Republic to Velehrad, a revered shrine associated with Saints Cyril and Methodius. Arrive in Brno for dinner and overnight.

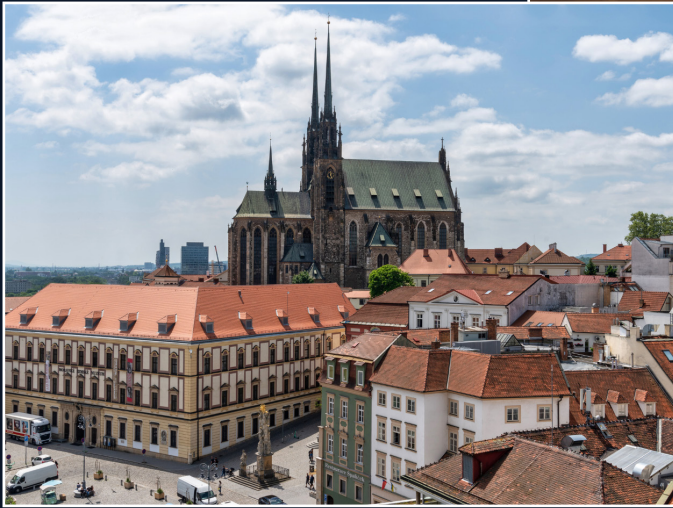

DAY 7: BRNO / PRAGUE

Discover Brno with visits to the Old Town Hall, the Cathedral of St. Peter and Paul, and the Motherhouse of the Mercy Sisters of St. Francis. Continue to Prague, where the afternoon is free for rest or personal exploration before dinner and overnight.

DAY 8: PRAGUE

Explore Prague's spiritual and cultural treasures, including the Loreto Shrine, Prague Castle, St. Vitus Cathedral, Malá Strana, St. Nicholas Church, and the Church of Our Lady Victorious, home of the Infant Jesus of Prague. Celebrate Mass, then continue to Old Town Square to see the Astronomical Clock before dinner.

DAY 9: SVATÁ HORA / PRAGUE

Travel to Svatá Hora, one of the Czech Republic's oldest and most beloved Marian pilgrimage sites. Return to Prague for an afternoon at leisure before gathering for a farewell dinner at a local restaurant.

DAY 10: RETURN HOME

Transfer to the airport for your return flight home, carrying cherished memories and spiritual blessings from your pilgrimage through Poland and the Czech Republic.



Travel Considerations



We strongly recommend purchasing "Cancel For Any Reason" travel insurance to protect your investment upon any unforeseen circumstances. We offer coverage or you are free to purchase from your own insurance carrier.

This pilgrimage itinerary may include early mornings, full sightseeing days, extended travel times, multiple modes of transportation, and moderate physical activity. Please review the full itinerary for complete details.

YOUR PACKAGE INCLUDES

Air Transportation: Economy class and round-trip airfares are based on the time of the reservation. Rates and times are subject to change without notice. Airfares, once issued, are non-refundable, non-transferable, and cannot be used towards future travel.

Private Transfers: All land transportation as described in the itinerary will be by Deluxe Motor Coach. Some may be equipped with Wi-Fi service.

Hotel Accommodations: Your hotels will be first-class with double occupancy (2 people per room with a private bath). Neither Nativity Pilgrimage nor the trip coordinator are responsible for providing a roommate.

Included Meals: The meal plan offers breakfast, lunch, & dinner daily.

Baggage: Most airlines limit passengers to one (1) piece of checked luggage and one (1) carry-on. All passengers should check with their airline carrier for up-to-date baggage weight and dimensions.

Airport Fees: Airport Taxes, portage, fuel surcharges and security fees

Medical Coverage: Medical coverage for the duration of your trip. Coverage details, limits, exclusions, and claims procedures are governed solely by the insurance policy documents provided by the insurer.

Tips/Gratuities: This includes tour guides, drivers, hotel service staff, and wait staff.

YOUR PACKAGE DOES NOT INCLUDE

Cancellation Insurance: We highly recommend purchasing travel insurance upon registration.

Passport/Visa Expenses: This includes any passports or additional travel documents that may be required. Passports must be valid until at least 6 months from your return date. Travelers are solely responsible for obtaining and carrying all required passports, visas, vaccination documentation, and other entry requirements imposed by destination countries.

Personal Expenses: Laundry, beverages (including wine, liquor, mineral water, tea, coffee, etc.), meals or food items not listed on the included menu plan, and any excess or additional luggage.

Non-itinerary fees: Any sightseeing or service fees or personal items that are not specifically mentioned as being included in the itinerary.

Non-included meals: You are responsible for any meals not specified in your itinerary.

GENERAL TRAVEL INFORMATION

Group Air Policy: Group Air differs from individually purchased airline tickets in that it is subject to the terms and conditions of the airlines. For this reason, we need to receive your registration and full payment by the payment deadline. After that date, registrations may be subject to a different air rate, ticketing method, or on a different airline. Additional fees and charges may apply. Group air flights are confirmed 60 - 90 days prior to departure.

Point of Departure: If your departure city is not listed on the brochure, indicate which airport you would like to depart from on the registration form. We will provide you with the best possible price and flight schedule to connect with the group. Additional fees and charges may apply.

Land-Only Option: If you would like to book your own air travel, indicate on your registration form that you want the land-only option. This amount equals to the total tour price minus \$800 for all destinations except Mexico, which is minus \$350. By booking your own air, you may select your seat, airline, and travel schedule, use airline miles/points, provide airline reward program information, and make any special requests directly with the airline. No changes can be made after the final payment deadline. Land-only services begin and end at the hotels unless you are able to meet the group at the airport. Land-only travelers are responsible for their own airport transfers.

IMPORTANT POLICIES

Travel/Scheduling Changes: Flight schedules, aircraft type, routing, departure airports, and carriers are subject to change by the airline without notice.

Seat Assignments: The airline carrier selects seat assignments for group air, not the tour operator. Seat upgrades are available for registered travelers, by request. Quoted rates for an upgrade are subject to change until payment is received. Some upgrades are not available until the group tickets are issued.

Single Room: Tour price is based on double occupancy. If you'd like a single room, there is an additional cost per person as specified on the registration form. Single rooms are limited and will be awarded on a first-come, first-served basis.

Seat Upgrades: Once Nativity Pilgrimage receives an upgrade or seat location request, we will contact the airlines to finalize your request. We cannot guarantee the acceptance of this request as it is subject to availability and pricing (which changes daily).

Special Requests: Once Nativity Pilgrimage receives a special request, such as a wheelchair, food, etc., we will contact the airlines to finalize your request. We cannot guarantee acceptance of this request as it is subject to availability and pricing (which changes daily).

TRAVELER CONDUCT POLICY

Nativity Pilgrimage reserves the right to remove any traveler whose behavior is disruptive, unsafe, unlawful, abusive, or interferes with the enjoyment or safety of other participants. No refund shall be provided for unused portions of the trip.

HEALTH/FITNESS REQUIREMENTS

Travelers are responsible for determining that they are physically and medically capable of participating. Travelers requiring special accommodations must notify Nativity Pilgrimage at the time of registration.

BOOKING CONDITIONS

Registration: An \$300 non-refundable deposit per person is required at the time of registration. No reservation will be processed without a deposit.

Payment Deadline: Full payment is due (02/01/2027) 100 days before departure. Late registrations received after the deadline require an additional \$100 (subject to availability). If payment is not made in full 50 days prior to departure, your payments are non-refundable.

Payment Methods: We accept major credit cards, checks, money orders, and Zelle payments. There is an additional 3% fee for each credit card transaction.

LATE PAYMENT POLICY

Customers will receive late fees if they are not paid in full:

- 100-61 days prior to departure: \$150
- 60-30 days prior to departure: \$300
- 30 days or less prior to departure: Subject to cancellation

Customers are also responsible for any difference in fare due to late payment (subject to availability). Refusal to pay will be considered a cancellation.

CANCELLATION/REFUND POLICY

Cancellation penalties are assessed based on the date written notice of cancellation is received:

- 100 days or more prior to departure: \$300 deposit
- 99-50 days prior to departure: 50% of total trip cost
- 49 days or less prior to departure: 100% of total trip cost

FORCE MAJEURE

Nativity Pilgrimage shall not be liable for delays, cancellations, changes, losses, or damages resulting from acts of God, natural disasters, pandemics, government actions, border closures, airline disruptions, labor disputes, terrorism, civil unrest, or other events beyond its reasonable control.

TRAVEL INSURANCE OPTIONS

Medical Coverage: Every pilgrim traveling with Nativity will receive complimentary medical insurance that provides coverage for the full duration of your trip. Coverage details, limits, exclusions, and claims procedures are governed solely by the insurance policy documents provided by the insurer.
